Ukrainian Center for Independent Political Research (UCIPR) is a non-governmental and non-partisan organization, a think tank that affects the state policies in the domain of democratic dimension. UCIPR was established in 1991.

UCIPR mission is to promote irreversibility of democratic transformations.

Our activities are aimed at promotion of democratic values and procedures in the domain of public policies and administration as it is this way that makes the state transparent and accountable and unites people into the civil society.

We are working to ensure that in Ukraine human rights are guaranteed, political environment is competitive, elections are fair and free, system of public authorities is balanced and local self-governance is effective. Citizens shall have conditions to influence the decision making both on the state and local levels and to monitor actions of the government both personally and through the network of capable civil society and political organizations.

Support to public political communications, transparency of political parties and evaluation of political risks

Among the most important tasks of Ukraine is its integration and cooperation with the major democracies in the world. In order for the partners of Ukraine to plan their actions, it is important to understand the potential developments in the country. By weighing the factors that influence the developments in Ukraine, UCIPR evaluates political risks and makes projections on whether the factors will persist or change. Document on political risk assessment is prepared in cooperation with external experts twice a year and is used by all groups both in Ukraine and abroad that are interested in additional sources of information for understanding of the political situation in Ukraine - banks, business groups, civil society and public authorities.

In the year of two snap elections that took place as a result of Euromaidan, political positions of the presidential candidates and those of political parties during the parliamentary elections were evaluated. Materials that help understand approaches and intentions of the candidates were published in traditional UCIPR bulletins "Your choice".

Institutionalization of political parties and their strengthening add weight so that they can bear political responsibility. Among the factors of such institutionalization are the stable financial support and compliance with the rules that ensure the transparency of the party funding. In 2014, analytical overview was prepared on the principles of financing the political parties by the state in the countries that have varied specific experience of such financing and border on Ukraine – in Poland and Germany. These surveys formed the basis for further development of legislation governing the activities of the political parties in Ukraine.



Development of procedures for representative and direct democracy

UCIPR was one of the initiators of the coalition of civil society organizations (CSO) "For Fair Referendum" designed to hold public awareness campaign on the risks of the legislation on referenda adopted in 2012. The most powerful Ukrainian CSOs that united in a network raised awareness in the mass media on the potential consequences of using non-democratic provisions of the laws on referenda. In cooperation with the experts from Election Law Institute, Center of Policy and Legal Reform, Internews-Ukraine, International Foundation for Electoral Systems, with the assistance from the law firm Lexfor and in cooperation with the Ministry of Justice of Ukraine, UCIPR experts

drafted the new version of the Law of Ukraine "On All-Ukrainian Referendum" and promoted the idea of reviewing this bill in Ukrainian Parliament.

In 2014, UCIPR experts were actively engaged in establishing the expert group under the auspices of the Reanimation Package of Reforms on the reform of electoral laws, together with experts from field-specific CSOs supported the powerful campaign on the the necessity to provide for transparent and inclusive electoral process that would include introduction of open party lists in the voting process; organized and participated in the public events in promotion of this idea.



Development of legal environment for civil society

In 2014, UCIPR experts focused on monitoring positive legislative innovations in registration procedures for civil society and charitable organizations.

UCIPR in cooperation with the partners developed and advocated for the amendments to the Law "On Volunteering". Efforts were joined to prepare the Bill No. 1408 that was registered by 15 Members of Parliament. The major achievements of this Bill are: abolition of bureaucratic registration procedures for volunteer organizations, reduction of the age of volunteers, right to individual volunteering,

elimination of the financially burdensome insurance and mandatory contracts.

Our experts advocated for inclusion to the Action Plan on implementation of the "Open Government" Partnership" Initiative (approved by the Cabinet of Ministers of Ukraine Resolution of 26 November 2014 No. 1176-p) the provisions on introduction of the following: 1) a new law on public consultations; 2) rights to support charitable organizations from the state budget; 3) obtaining the non-for-profit status during the registration of the legal entity using the one-stop-shop (single window) principle.



Civic education and counseling for civil society organizations

School of social action

In spring of 2014, social activities soared in Ukraine. Understanding the needs of this target group, UCIPR held the School of social action for 285 people from the following regions of Ukraine: Khersonska, Kirovogradska, Dnipropetrovska, Chernihivska, Kharkivska, as well as Zakarpatska, Lvivska and Rivnenska regions.

This School helped new activists gain knowledge on how:

- to influence the decisions of the city council,
- to register a civil society organization,
- to hold a peaceful assembly,
- to access public information,
- to monitor the fairness of public procurements.
- to influence the formation of the local budget.

Starting from July 2014, UCIPR launched the Hot Line for registration of civil society and charitable organizations. Tel.: +38 (044) 227-5420. Public activists from the entire country

receive samples of documents and advice on registration of organizations or amendments to the Charters.

Information booklets

UCIPR experts paid significant attention to the legal education of community and development of local democracy. 8 information booklets on legal procedures to influence the decisions of the local governments were selected and distributed:

"How to hold public hearings"

"How to conduct public evaluation of local council activities"

"How to submit a draft decision to the city council by way of local initiative"

"How to get information from public authorities"

"Local referendum in Ukraine"

"Your influence on the local authorities: new opportunities"

"How to hold a general meeting of the members of the territorial community"

"How to hold consultations with the community"



Culture of dialogue, socio-cultural policy, prevention of conflicts in communities

UCIPR partnered with CMI (Crisis Management Initiative – Martti Ahtisaari Centre) to implement dialogue initiatives regarding the political resolution of the conflict in some localities of Donetsk and Luhansk regions in 2014. As a part of this initiative, regular meetings and consultations are held with experts and politicians with the view to resolve the situation, to find ways and scenarios to end conflict, international practices that led to political resolution http://goo.gl/KLWt81 are investigated.

This Initiative provides framework to hold seminars for members of Parliament, officials of the President Administration to get acquainted with diverse practices and political measures to resolve conflicts, to find political mechanisms for respective processes.

UCIPR experts extensively cooperate with various dialogue initiatives and projects of civil society organizations, in particular, on holding working meetings, trainings on conflict analysis and prevention. For instance, ongoing cooperation was established with "Youth Alternative", a non-governmental organization that facilitates education in democratic practices in youth environment and prepares interns for Verkhovna Rada of Ukraine and other public authorities. http://goo.gl/iNBWqH

UCIPR experts held trainings on conflict prevention, advocating for civil society initiatives as a way to prevent conflicts in communities together with the experts of Institute for International Cooperation of the German Adult Education Association (DVV International) http://goo.gl/Op1Clk



Rights of national minorities and indigenous people, policy development and advocacy

UCIPR experts became the members of the Council on Interethnic Concord at the Cabinet of Ministers of Ukraine when the Government introduced the post of Ombudsman for Ethnic Policy.

UCIPR cooperates with the Office of OSCE High Commissioner on National Minorities within the frameworks of implementation of monitoring initiatives to ensure the rights of the national minorities.

UCIPR experts are the members of the Expert Council at the Verkhovna Rada Commit-

tee on Human Rights, National Minorities and Interethnic relations. We took part in drafting the National Strategy on Human rights in compliance with the President of Ukraine Decree of 15 October 2014 No. 811/2014, in particular, with regard to ensure the national minority rights, to identify new challenges related to human rights in the temporarily occupied and uncontrolled territories.

UCIPR experts participated in drafting the Law of Ukraine "On the Status of the Indigenous Peoples in Ukraine".



Human rights in the Crimea, analysis of processes

In 2014, UCIPR concentrated its activities on monitoring and analyzing the situation around the Crimea that was occupied and annexed by the Russian Federation.

In 2014, the following Legal comments were drafted for the citizens of the annexed Crimea: citizenship, documents, crossing the border, welfare payments, financial transactions, etc. Topics were selected based on the common issues raised during interviews with the Crimeans.

Experts of UCIPR Support to Democratic Processes program prepared the first ever in Ukraine public informational and monitoring report – "Annexed" education in the temporarily occupied Crimea" http://goo.gl/eg35wc that sets forth the summarized description of the situation related to education in Ukrainian and Crimean Tatar languages in the Crimea following the annexation of the peninsula.



Advocacy for discrimination combating practices

UCIPR experts are the members of the Coalition for Combating Discrimination in Ukraine (CCD) http://goo.gl/FGmYe1. The purpose of the CCD is to promote the ideas of equality in the society, formation of legal and institutional tools and mechanisms to ensure such equality. In 2014, UCIPR experts joined in to launch information-

al campaign to promote equality in the society, in particular, the studies were carried out that helped actualize various stereotypes existing in the society with regard to vulnerable groups.

In 2014, coalition made a number of statements on discriminatory manifestations in the Crimea on the part of the Russian occupants.



Support to European integration processes

In 2014, UCIPR joined in to form Ukrainian side of the EU-Ukraine Civil Society Platform in compliance with the Articles 469-470 of the EU-Ukraine Association Agreement. UCIPR experts contributed to coordination of the Work Group 3 "Human Rights, Gender Equality and Non-discrimination": the activities resulted in the monitoring report that allowed to evaluate

the implementation of the agreement in the areas of ensuring the national minority rights, non-discrimination and gender equality.

UCIPR is among the founding members of the Ukrainian Think Tanks Liaison Office in Brussels. In 2014, UCIPR experts took part in informational and analytical activities of the Office that featured elections and situation in the Crimea.

PUBLIC ACTIVITY

From the moment it was created, UCIPR have become an integral part of the civil society and takes pro-active position during pivotal moments in Ukrainian history.

Our efforts have always been directed to promotion and facilitation of civil action.

In 2014, during the Revolution of Dignity, UCIPR employees took part in protests of the civil society against corruption, abuse of power and suppression of political rights of Ukrainians.

We took part in mass protests and joined in to organize cultural and educational events during Euromaidan. In particular, we joined in to launch the Open University of Maidan.
